- Marianne raised that the National Sprints would like to offer funds to FGPC for boat wear and tear, and trailering expense.
- There was a short discussion around the RME grant allocation. As there were no definitive proposals at the meeting, the board will address this at upcoming board meeting to see if any changes should be made to the way this grant is allocated.

8. IVF Report and Budget

- As attached, reviewed by Lynda, Canada's IVF Representative
- Paddlers are interested in how much money and training will be offered by CORA at the outset before tryouts. A budget for the Team Canada experience would be helpful to educate potential team mates. Last year was the first year CORA contributed to fund Team Canada. CORA will continue to contribute with a finite amount of investment, but there will not be a model where athletes are paid to participate. Lynda will be clear in budget expectations and who carries the portion of each cost. Tahiti 2018 Sprints will be less support per person as Canada will be sending approximately 60 paddlers. Funding will be directed to training camps.
- IVF intends for paddlers from across Canada to be represented at events. It is acknowledged that it is impractical and logistically difficult for paddlers geographically distant to train together. The IVF selection committee will keep this in mind and where possible look at forming regional crews.

Though 2017 has presented a number of challenges for the board, overall it has been a successful year with few incidents. We continue to work on ways of giving back to and assisting our clubs and members, guiding race organizers in putting on as safe an event as possible, and the board is always here to assist with any issues that may arise. The board realises that we must continue to work diligently to adjust with a evolving membership.

After many hours of review and consultation, the updates to the distance race rules were completed. While much of the update included streamlining the wording for clarity and adding consistency to the terminology there were some other significant changes. The age classifications were updated in order to more closely reflect IVF age classifications, the CORA turn rule was added to the body of the document making it easier for all members to find and review, and a new winter small boat pfd rule was added for paddler safety. It is every members' responsibility to review the CORA race rules which can be found on the website.

There has been a significant increase in the number of clubs purchasing ultralight OC6s, and with more and more entering Iron events this past year we have had to acknowledge this. There was discussion weather to create a new "Ultralight" boat category within the race rule update, however in the end it was felt that this was already covered under the "Open" category and that a new classification was not needed. Crews racing underweight boats (less than 400 pounds) always have the option of racing open class or adding weight to bring them up to spec class.

Over the past couple years there was a concerted effort to look at what long term initiatives CORA should be focussing on. Last year through a special pre-AGM meeting we identified three clear areas of focus; Coaching, IVF, and Communications. These directives seem to have been echoed by our membership as evidenced by results from the recent member survey. The board will continue to work on these goals by developing new resources, reviewing funding structure, and improving our web based communications.

Membership numbers continue to grow both in the number of member clubs as well as individual members. With online membership renewals increasing year over year the workload we put on our membership coordinators, especially at the beginning of the year, continues to decrease, they thank you. I encourage members to continue this trend as it is clearly the best way to record your information and reduce input errors.

The CORA Cup Championships saw a new venue this year giving all those that participated a chance to experience the conditions and scenery of Harrison Lake. Thank you to Fraser Valley Dragon Boat Club for your hard work and hospitality.

It was a very successful year with our grants disbursement with all three grant categories, Travel, Repair Maintenance & Equipment (RME), and Coaching & Education, being awarded to the full extent of their respective budgets. We continue to look for new ways to support our membership through grants while maintaining fair and equitable policies for all.

With the addition of a distance event by the IVF, what was formally known or referred to as "Sprint" within CORA will now be simply referred to as IVF. The addition of IVF World Distance Championships in alternate years to the IVF World Sprint Championships means there is an increased and constant level of

CORA COMMUNICATION DIRECTOR'S REPORT - 2017

CORA continues to attempt to improve its communication with its existing membership and potential new members through its website and social media offerings such as Facebook, YouTube and twitter.

CORA website:

There were 41,000 visitors to the CORA website in 2017 down slightly from 43,441 in 2016, and 42,145 in 2015. This equates to 3416 visitors per month or 112 per day. The average amount of time that a visitor spent on the site was 3 minutes and 14 seconds. Other website stats include:

- 57.3% accessed using a desktop – down from 62% in 2016
- 26.5% accessed using a mobile phone – up from 22% in 2016
- 16.2% accessed using a tablet – up from 16% in 2016

Similar to other years, the most popular pages viewed were:

- Home Page - 95,572 views
- Race Schedule – 34,110 views
- Race Results – 28,272 views
- Buy & Sell - 16,919 views
- CORA Championships - 8,926 views

Visitors to the CORA website were primarily from:

- Greater Vancouver 38%
- Greater Victoria 13%
- Calgary with 5%
- Ontario 3.5%

The small decrease in website visits during 2017 has been more than compensated for by significant increases in social media interactions through Facebook, YouTube, and Twitter.

Facebook:

CORA continues to rely increasingly on Facebook to keep in contact with its membership and expand its reach to potential new members

Likes of the CORA Facebook page reached 865 in 2017 up from 781 in 2016 and 662 in 2015.

- 55% were women
- 41% were male
- 82% were aged 35 years or older while less than 5% were under 25 years of age

There were 80 posts to the CORA Facebook page in 2017 up from 70 in 2016 and 60 in 2015

68,953 people were reached through Facebook in 2017, 40% more than were reached during 2016 (49,017) and almost 2.5 times the numbers that were reached during 2015 (27,888).

Of the 68,953 people reached during the year, 13,494 (20%) clicked through to view the post and of those 7,186 (53%) liked, commented on or shared the post.

The average number of people reached per Facebook post in 2017 was 862, over 20% higher than the reach per post in 2016 (700) and almost double the reach per post in 2015 (465).

Some Facebook posts in 2017 reached as many as 7,000 people which means we are extending out well beyond the current membership to new potential members through member shares with their non-CORA Facebook friends.

YouTube:

CORA created a new YouTube channel in 2013 and has posted several outrigger educational videos which it sponsored the production of between 2013 and 2015 which include:

- Huli Tutorial: Uploaded 3 yrs ago, Total Views: 18,673, Views in 2017: 8,042

- Rope Rigging Iako to Hull Tutorial: Uploaded 2 yrs ago, Total Views: 665, Views in 2017: 479

Twitter:

CORA also has a Twitter account which is setup to automatically tweet any posting that is made to our Facebook page.

The CORA's Twitter account currently has 487 followers up from 448 in 2016 and 379 in 2015.

Summary:

In an attempt to increase the awareness of CORA's communication offerings we are recommending that member clubs and individual members continue to link to CORA's website, Facebook page and YouTube videos from their own websites and make a concerted effort in 2018 to like, share and comment on CORA's Facebook page and Facebook postings.

2017 CORA AGM, IVF Report

World Long Distance Championships. June 2017. Recap.

Canada had entries for 3 events: Open Men and Women, Masters women, in addition to entries in the respective V1 events.

Results:

Open Women V6: 4/14 crews. Leanne Stanley V1, 4/14 entries.

Masters Women V6: 6/10 crews. Kamini Jain V1, 5/14 entries.

Open Men V6: DNF / 18 crews. Len Morris V1, 14/23 entries.

Great performance by all paddlers including the men, so close to finishing but were swamped and unable to continue. Super team support from all paddlers. Host issues created some challenges for the girls set up in the host accommodation. Based on rooms and food service we will encourage Sprint paddlers to book houses.

Great to see the Geronimo boys participate in the Cultural Night performance.

IVF Meetings Oct, Tahiti 2017 and 2018.

We continue to work on updating and improving our Operations documents, (strategic plan, distance rules, etc)

We have recently signed a cooperation agreement with the ICF in order to work together for the development of the va'a (specifically for the inclusion with the Paralympics).

World Sprint Championships

2018, Tahiti – July 16-26

Team Canada has been selected. We are currently at 58 paddlers.

Team Canada is represented in the following categories:

- Elite Open Men and Women
- Open, 40's, 50's, 60's and 70's men and women's crews
- In addition each age and gender category have filled all entries for V1 slots.
- No para or juniors have entered.

2018 Plans

Team Selection for 2018 Sprints is complete, we intend to set 1-2 training camps based on the approved 2018 CORA race schedule prior to mid July.

- Encourage all crews to attend the National Sprint Championships in late April.
- Team Uniforms need to be organized
- Kristine Malmqvist will be the Area Coordinator for Team Canada with support from Lynda who will also attend and be working with the IVF and the host to assist with the event.

Long Distance IVF Project.

- James and Leanne have set a preliminary timeline of events for the 2019 Distance program including team selection process and training camps. The objective is to name Team Canada Distance teams for approval at 2018 CORA AGM (full draft schedule available)

Dates for upcoming IVF events are as follows:

- 2019, Australia, World Long Distance – Dates tbc, likely mid August
- 2020, Hilo, HI, World Sprints – August 16-23 (tbc)
- Sprint and Distance bids for 2021, 2022 will be reviewed at the 2018 AGM in Tahiti.

2017 Safety Report – Gralin Doubleday

1. Few to no reported incidents
2. Winter small boat PFD rule added to the distance race rules
3. Questions concerning Vaikobi PFDs
 - a. After discussion it was determined they are acceptable under CORA current rules as being approved by a government authority equivalent to Transport Canada. As we understand it they are approved in Australia and New Zealand, and Vaikobi is currently seeking approval in Canada.
4. Encourage all clubs to develop and maintain their own safety policies/manual based on their localized conditions.

Junior/Novice Report

GOAL:

Developing, adapting and promoting paddling opportunities to juniors in our community.

Ideas:

The following are from discussions with younger paddlers, what makes them interested in paddling, wanting to start paddling and wanting to continue. There will always be youth who try it but don't return, but what can we do to lessen the percentage of attrition.

Mentorship for the older paddlers:

- Providing opportunities for coaching courses leading to certification
- Providing opportunities to take on more responsibilities within clubs, such as assisting with race organization or assistant coaching.
- Providing opportunities to meet or have a clinic with well-known paddlers (Danny Ching, Dion Maxwell, Mary Smolenski, etc)

Fun and Introductory Events:

- Shorter course races. Not just a novice or short course race at the iron events
- Special paddles – Halloween, Christmas paddles, destination paddles (eg; coffee shop)
- Spring Break camps
- Summer camps
- Skills race (test of various paddling skills)
- Dragon boat or SUP paddling
- Fun team-building opportunities (camping, challenge games, social events)
- Opportunities to socialize and/or mix with more experienced paddlers

Goal races:

- Queen Lili is a great goal race, partly because it is series of races
- Island Changes – shorter course 20 km
- Nationals shorter course
- In club Skills Race
- Jericho Iron and Lotus Iron short/novice courses, FCRCC March Madness, Lotus Ice Breaker V12, FGPC V12-V21 and ORPC Bridges

How can CORA help:

- 1) Encourage clubs to offer short course races. The excitement for junior and novice teams to race against and learn from more experienced teams is invaluable. Not just sprint races but races that are less than 8 km.
- 2) Education Grants – in order to be certified to coach you must complete two NCCP Courses and a ELCC course valued at approximately \$150.00 each. There is also a cost to be certified. Total cost for the process is approximately \$550.00.
 - a. CORA education grant is currently \$250.00 per person, maximum of two people per club per year.
 - i. Suggestion that the grant requirements be that someone must commit to completing their certification within the year, from the date of the first course, and CORA will reimburse.
- 3) Establish a fun transition program with consistent coaching to introduce junior dragon boat racers to outrigger paddling

What is CORA doing already:

- 1) Encouraging clubs to charge a reduced registration fee for junior teams
- 2) Encouraging clubs to have canoes rigged and ready to race for junior and novice teams, particularly for the teams that travel to the races.
