- d. Grant Updates Ron

Some clinic grants need to be completed with receipts for reimbursement before the next applied grants can be considered. Once clinic will be reviewed for eligibility – re: first aid clinic.

Travel grants – applications for the rest of the season have been received. The total applied for works out to \$1250 under the budget.

Clinic grants - \$2800 remains. Additional grants have been applied for which could almost use the entire budget.
