



**JUNIOR INFORMED CONSENT AND
ACKNOWLEDGEMENT OF RISKS**

*****PLEASE READ CAREFULLY*****

VIRTUAL SPRING SERIES SMALL BOATS RACE #1
April 17 through May 2, 2021 (the "Event")**

BY PURCHASING A RACE ENTRY FOR A JUNIOR MEMBER, I ACKNOWLEDGE THAT I AM THE PARENT OR GUARDIAN OF THE JUNIOR MEMBER AND CONSENT TO THE JUNIOR MEMBER'S PARTICIPATION IN THE EVENT.

AWARENESS OF RISK: I, the undersigned parent or legal guardian of the junior participant named in the race entry (the "**Junior Participant**"), confirm that as the Event is a virtual race which entails the submission of individual timed results over a discretionary race course meeting CORA-specified requirements, I confirm that I will assist the Junior Participant in selecting the race course and will use reasonable judgement with a view to the Junior Participant's safety in selecting the day, time and weather conditions for the Junior Participant's race, and whether the Junior Participant should be accompanied. I will endeavour to see that the Junior Participant complies with all COVID-19 health orders applicable to the race location before, during and after the race. I am aware that the participation of the Junior Participant in the Event involves risks inherent in paddling sports, both on and off the water, including risk of personal injury, death, property damage, expense and related loss, including, without limitation, loss of income and such risks arising from the negligence of the CANADIAN OUTRIGGER RACING ASSOCIATION ("**CORA**"), COMOX VALLEY CANOE RACING CLUB, CITY OF COURTENAY, VANCOUVER OCEAN SPORTS (VOS), HER MAJESTY THE QUEEN, VANCOUVER FRASER PORT AUTHORITY, CITY OF VANCOUVER, VANCOUVER BOARD OF PARKS & RECREATION & AFFILIATED COMMUNITY CENTRE ASSOCIATIONS & SOCIETIES AND THE VANCOUVER POLICE BOARD AND THEIR OFFICIALS, OFFICERS, EMPLOYEES, SERVANTS, AGENTS & VOLUNTEERS, and/or other participants and owners of the facilities where the Event will occur and their respective directors, officers, members, agents, officials, organizers, volunteers and other representatives (collectively, the "**Hosts**") and from other Event participants. I confirm that the Hosts make no representations as to the Junior Participant's safety during the Event. I have informed the Junior Participant of the risks associated with participating in the Event.

INFORMED CONSENT: I am the parent or legal guardian of the Junior Participant and I hereby freely consent to the Junior Participant's participation in the Event. I acknowledge that the Junior Participant is voluntarily participating in the Event for his or her benefit and enjoyment, despite being informed of the risks associated therewith.

MEDIA RELEASE: I hereby grant CORA to use and publish submissions provided by the Junior Participant, including photographs, screenshots, GPS tracks or other data, with or without his or her name, through CORA's website content, and neither I nor the Junior Participant shall not be entitled to any monetary compensation of any kind in respect thereof. I hereby consent to the use of the Junior Participant's personal information for CORA-related purposes, including e-mail communications. CORA will not sell or provide personal information to any third parties for any other purpose without written consent.

GENERAL PROVISIONS: This Agreement shall be binding on not only me, but my next of kin, heirs, executors, administrators and assigns. If any provision of this Agreement is held invalid or unenforceable, it will be severed herefrom and will not affect the validity or enforceability of the remainder hereof. This Agreement sets out the entire agreement between the parties regarding the subject matter hereof and may not be amended. This Agreement shall be governed by the laws of British Columbia, Canada.

I CONFIRM THAT THE JUNIOR PARTICIPANT HAS READ AND UNDERSTANDS THE RISKS DESCRIBED ABOVE.

I CONFIRM THAT:

(i) I AM THE PARENT OR LEGAL GUARDIAN OF THE JUNIOR PARTICIPANT WITH THE RIGHT TO CONSENT TO SUCH JUNIOR PARTICIPANT'S PARTICIPATION IN THE EVENT; (ii) I HAVE READ AND UNDERSTAND THE TERMS OF THIS AGREEMENT; AND (iii) BY SIGNING THIS AGREEMENT I AM GIVING UP CERTAIN LEGAL RIGHTS THAT I OR MY LEGAL REPRESENTATIVES MAY HAVE. I ACKNOWLEDGE THAT I HAVE BEEN GIVEN THE OPPORTUNITY TO CONSULT A LAWYER FOR INDEPENDENT LEGAL ADVICE.
