 RME Grant Application received from Maple Bay Ocean Canoe Club MBOCC has 20 annual CORA Members and has renewed its Club membership for 2024.

Justification: We have 2 X OC6 spec canoes, which are wheeled about 150 metres to/from our boat ramp. We are requesting grant monies to assist with maintaining the canoe carrier wheel sets (X 4), as well as repairs to zippers on the canoe skirts, new ratchet straps and line for ama lashings, and materials for renewing iakos and maintaining and minor repairs to gel-coat. We intend to purchase a second club steer paddle for

smaller members who find the larger biscuit to be a bit challenging to handle.

Expense Estimate: Wheel sets- \$200.00, zippers - \$100.00, ratchets - \$150.00, maintenance supplies - \$50.00, steer blade - \$500.00

CORA 2024 Canadian National Sprints Championships Deas Island

CORA Sprints Registration page and CORA Sprints Event page and CORA Sprints FAQ page have been kept current and are in lock-step. - **Graeme**

VIASport Requested Amount (\$10K) & Awarded Amount (\$5K) clarified with CORA Treasurer. - **Graeme**

Made a visit to Deas Island **2024-Mar-25** at low-tide and high-tide and paddled my V1 the whole length of the 1000M channel on both sides of the channel and down the middle of the channel taking depth readings with a lead weight to assess the depth variation east-to-west and south-to-north. Those observations were shared with DDRC. - **Graeme**

Made a visit to Deas Island **2024-Mar-30** at low tidal conditions identical to what will happen during the 2024-Apr-27/28 weekend. The shoreline east of the dock was wide and solid-footing for ease of water access for loading / launching 12 V6s. The dock was barely off the channel floor with 1'-6' of water on the westside and 2'-7' on the eastside. There were 2 wedding party limo buses in the gravel parking lot and 50-60 wedding party guests taking photos on the dock and enjoying the green space (see photos (**DI-Low-Tide-20240330...**) in Google Sprints Venue Deas Island folder). - **Graeme**

Have CORA Board members yet to schedule a site visit after 4+months of being implored to see the venue first-hand to familiarize themselves with venue logistics? - 2 Board Members finally did a site visit on 2024-Apr-4.

Do we have an estimate of Paid Registrations (V6 & V1) as of the 2024-Apr-1 CORA Board Meeting? - Treasurer has shared ~60 OC6 Crews & ~40 V1 entries as of 2024-Apr-6

The V6/V1 Canoe Sponsor was **awaiting a letter from CORA to Canada Customs** to expedite import of canoes into Canada. Has this letter been provided? This has already **delayed import of ARE V6/V1 canoes** into Canada by at least 3 weeks - **ARE Rep moving forward with a backup plan to import canoes into Canada**

The V6/V1 Canoe Sponsor expects to have canoe trailers delivered to Deas Island Regional Park by Thursday afternoon (before 8PM). Ken Ang will be towing the Mako V1 (15) trailer. **Who will be towing** the 2 Matahina V6 (6 per) trailers and can we

guarantee delivery as expected? **Update as of 2024-04-03 ~ Ken Ang has all of this covered.**

CORA agreed to provide **24 bailers** for the 12 V6s. CORA has been able to source 25+ used cylindrical bleach containers with handles and caps from the Vancouver Transfer Station at Zero cost (with more next week). - **Graeme / Ron**

CORA noted that **72 PFDs** (for 12 V6s) would need to be provided (V1 PFDs to be paddler-provided). Who has taken responsibility for this and what is the status? - **No updates on this task**

CORA noted that 5 **flags** (1 White; 1 Red; 1 Green; 2 Black) would need to be provided. Who has taken responsibility for this and what is the status? - **Ron collecting flags**

CORA noted that 12 V6 **boat numbers** and possibly 15 V1 boat numbers would need to be provided. Who has taken responsibility for this and what is the status? - **Erik providing V6 & maybe V1 boat numbers**

CORA noted that CORA did not wish to engage with Delta Amateur Radio Society (DARS) and that CORA Board members would source an adequate number of radios for communication between all venue stations. Who has taken responsibility for this and what is the status? - Jonathan handed off responsibility to Ron

Do we have an estimate and staffing / equipment plans and contractual agreement with a Timing / Race Management service provider (staffing; equipment - computers; printers; cameras; timers; binoculars; stop-watches), and if not, when can we expect to have this in place? If this is an event risk, should CORA consider engaging with other potential established Timing / Race Management service providers? - Staffing plan incomplete. No Contractual Agreement in place.

Do we have an estimate and staffing / equipment plans and contractual agreement with an Event Management service provider (staffing; equipment - porta-potties; generator; canopies; tables; chairs; tires; meals / beverages), and if not, when can we expect to have this in place? If this is an event risk, should CORA consider engaging with other potential established Event Management service providers? - Proposed Budget received far in excess of previously quoted equipment needs. Staffing plan incomplete. No Contractual Agreement in place.

Delta Deas Rowing Club (DDRC) have confirmed their support for this event in terms of racecourse setup/takedown (CORA-provided turn buoys), safety boats, utilities (power/water) access, dock access, compound worker meal / beverage shelter, overnight canopy / tables / generator storage subject to CORA SPOC. - **Graeme**

Delta Outrigger (DOKA) have confirmed their support for this event in terms of volunteers (6-8), V6 dollies (2), PCOC certified safety boat drivers (2), and compound access subject to CORA SPOC. - **Graeme**

Metro Vancouver Regional District (MVRD) has confirmed their support for this event in terms of clearing rogue logs from the shoreline and provision of 6-8 folding tables from their Service Yard facility. - **Graeme**

City of Delta has confirmed their support for this event in terms of giving their OK for having the Officiating Station with 1 generator on City property along the Millenium Trail. - **Graeme**

Dragon Zone has confirmed their quote / availability of 4 pop-up 10'x10' canopies from Friday PM to Mon AM for \$60/Canopy/Day = \$250+Taxes - **Event Management estimate far in excess of Quote received.**

Super Save has confirmed until 2024-Apr-12 their Non-Profit Discounted quote / availability of 4 porta-potties from Friday PM to Mon AM for \$250/Each/Day = \$1000+Taxes (Quote uploaded (DI-SuperSave-Porta-Potty-Rental-Quote-Discount-Simi.jpg) to Google Sprints Venue Deas Island folder) - Event Management estimate far in excess of Quote received.
